

# **MAIN ACHIEVEMENTS IN 2022**

#### The rule of law



We organized the fourth edition of the Forum "Justice and Anticorruption Reforms Forum"

- the main platform for justice actors, politicians, civil society and development partners to debate justice.



The authorities have benefited from the legal expertise of the LRCM on initiatives to amend the legal framework in the Republic of Moldova, such as the adjustment of legislation to the constitutional changes of 2022, the new law on the Supreme Court of Justice, the amendment of the criminal procedure or the legislation on the National Institute of Justice.



Approximately 200 students, journalists and justice professionals attended our public lectures, trainings, and seminars.



We published 12 newsletters for the more than 2,000 subscribers of the MCRC, providing a retrospective of the most important events concerning the rule of law in Moldova, which we summarized in four videos.



We analyzed how the justice system in the Republic of Moldova is financed and how efficient it is compared to the justice systems of European countries.

# Integrity and the fight against corruption



We examined how effectively corruption is sanctioned in the Republic of Moldova. We also launched a podcast about who fuels corruption in Moldova, how it is investigated and what punishments are applied.



We have helped the National Integrity Authority to improve its procedures for controlling assets and interests.



We monitored the work of the Integrity Council and analyzed the acts issued by the National Integrity Authority and the judicial practice in relation to them.



We have provided legal expertise to the authorities on amending extended confiscation legislation and proposed deterrent sanctions for corruption.

### **Human Rights**



For the 12th consecutive year, we have produced the summary of violations found by the ECtHR in Moldovan cases, for the year 2021, a summary of violations of Article 3 of the ECHR. as well as a summary of all violations found by the ECtHR in Moldovan cases over the last 25 years.



Together with other civil society organizations, we have called on the Parliament to strengthen the capacity of the Equality Council and on the Justice authorities - to bring justice to the illegal expulsion of Turkish teachers.



More than 30 justice professionals (judges, prosecutors and lawyers) were trained on the right to a fair trial.



We presented in graphic and video format the concept of Human Rights Defender.



We have published five other videos on the ECtHR and two podcasts on hate crimes and hate speech.

## **Democracy and Civil society**



We promoted the 2% mechanism and trained over 50 civil society organizations on how to raise funds through this mechanism.



We organized the sixth edition of the "Applied Democracy School", where 18 young people learned how they can participate in building a genuine democracy.



Following the war in Ukraine, we provided pro-bono legal support to foreign organisations on the registration procedure in the Republic of Moldova.



During a round table discussion, we debated with the authorities the role of civil society in the national money laundering risk assessment.



33 journalists, public authorities and civil society representatives attended a practical workshop on digital security organized by us.



In 2022, we were financially supported by the Embassy of the United States of America, the Embassy of the Kingdom of the Netherlands, the European Union and the Soros Foundation Moldova.
