#### **SUMMARY**

The new Law on the Prosecutor's Office, adopted in 2016, significantly changed the structure of the prosecution system. The law established the Superior Council of Prosecutors (SCP) as an independent body formed to participate in the process of functioning and ensuring self-governance of the prosecution system. The SCP is the guarantor of the independence and impartiality of prosecutors. According to the law, the SCP meets as often as necessary, but at least once a month. SCP meetings are public, unless the SCP decides that a meeting or part of a meeting should be closed in order to respect the personal data regime or other restricted information. This paper examines how the provisions relating to the transparency of the work of the SCP were applied and complied with in practice during the period from 1 January 2020 to 30 June 2023.

During the monitoring period, we noticed that within the SCP, the discussion of issues in closed session and 'in deliberation' seems to be the rule, while a public session is the exception. Approximately one third of the issues considered by the SCP were discussed without access by society. Most of the contentious issues were discussed 'in deliberation', with no clear reasoning given by SCP members for their decisions. The Prosecutor General's requests were accepted without debate, especially between 2020 and 2021. During the remainder of the monitoring period, the Acting Prosecutor General's requests could be discussed in session, while decisions were again taken 'in deliberation'. The report recommends strict adherence to the legal requirements that business be conducted and discussed in open session, and that closed meetings be used only when really necessary.

Out of a total of 109 SCP meetings scheduled, 90 (83%) were held and 19 (17%) were postponed due to lack of quorum. The quorum was not achieved mainly due to the absence of de jure and/or civil society members of the SCP. While between 2020 and 2021 meetings were mainly held on 'Thursdays', from 2022 onwards SCP meetings were scheduled unpredictably. This may explain the increase in the number of postponed meetings. SCP members should establish a predictable day of the week on which regular meetings are held, but also cooperate with each other in preparing the agenda and the topics proposed for discussion.

Of the 31 supplemental agendas, which contained 39 subjects, the majority came from the Prosecutor General, including the Acting Prosecutor General, and related to transfers, promotions, securing interim appointments, etc. These subjects are not in the category of non-deferrable subjects and could have been included in the regular agenda so that all SCP members had sufficient time to consider them.

Only 23 (4%) of the 568 decisions of the SCP were published on time on its official website. On average, an SCP decision is published within 42 working days, which is four times the legal deadline. It was found that some SCP decisions were published more than 520 working days after their adoption, while others had not even been published as of 2021. The most recent decisions concerned the consideration of disciplinary appeals. The problem of late publication of SCP agendas and decisions could be alleviated by increasing the number of staff in the SCP administration. The report also recommends the use of electronic signatures by SCP members to make it easier and quicker for them to sign the decisions issued.

The reasoning of SCP decisions is usually vague, with more emphasis on legal circumstances and technical implementation of legal provisions, without detailing the SCP reasoning behind a decision. This practice was most often noted in the case of the approval or rejection of interim positions in the prosecution system. The report also proposes to ensure that each candidate is heard individually on the basis of a questionnaire and to resume the practice of publishing the minutes of SCP meetings, as provided for in the SCP Regulations.<sup>1</sup>

#### INTRODUCTION

#### **Background and Purpose of This Paper**

On 25 February 2016, the Moldovan Parliament adopted a new Law on the Prosecutor's Office<sup>2</sup> which entered into force on 1 August 2016. The law established the Superior Council of Prosecutors (SCP) as an independent body with the status of a legal entity, established to participate in the process of functioning and ensuring the selfgovernance of the prosecution system. The SCP is the guarantor of the independence and impartiality of prosecutors.

The Legal Resources Centre of Moldova (LRCM) previously reviewed the appointment and promotion process of prosecutors carried out by the SCP during 2019-2021.3 The LRCM reviewed all completed competitions for the positions of prosecutor, deputy chief prosecutor and chief prosecutor in all prosecutor's offices in the country, including the Prosecutor General's Office. We found that the system did not fully encourage competition between prosecutors. 4 We were then unable to determine whether the SCP had advertised all existing vacancies for competition, as required by law, because the SCP had not published all vacancies in the prosecution system on the Internet.

This paper reviews how the provisions on transparency of SCP activities have been applied and complied with in practice during the period from 1 January 2020 to 30 June 2023. We have chosen this particular topic because of the importance of this aspect in ensuring the independence of prosecutors and strengthening the activities of the current and future composition of the SCP. The fact that no similar research has been carried out since the new law on the Public Prosecutor's Office came into force also contributed to this choice.

For example, 20 of the 26 senior positions posted (77%) had only one applicant. Six positions had two or more applicants. For two of the six positions, applicants withdrew from the competition before it was completed, leaving only one applicant. Finally, only four (15%) of the 26 senior positions were filled as a result of a competition with two or three applicants. These figures confirm that, in most cases, senior positions in the prosecution service were filled without any real competition. Seventeen out of the 26 senior positions that were advertised (65%) were filled by candidates who already held an interim position for which they were applying. They had been appointed on an interim basis by order of the Prosecutor General after previous Chief Prosecutors had resigned or their terms of office had expired. These figures confirm that in at least 65% of the cases, the Chief Prosecutors were indeed identified by the Prosecutor General and formally appointed on the basis of a competition organized by the SCP.

#### Methodology

The aim of the research is to examine the transparency of the activities of the SCP. In particular, it examined how meetings are organized and conducted, how rules regarding the publication of meeting agendas and minutes and SCP decisions are followed, how rules regarding the discussion of issues in open versus closed meetings are followed, the activism of SCP members, the consistency of their votes and the existence of dissenting opinions, and how decisions adopted are justified.

Research methods: review of the SCP website (www.csp.md), observation of SCP meetings in live and/or archived formats, review of SCP activity reports, decisions and information on the settled agenda, etc. We also conducted a round of interviews with some SCP members to discuss issues related to the work of the institution.

In order to determine the date of publication of an agenda or a decision on the official website of the SCP, we used the option "PDF document properties", where the date of creation, modification and, implicitly, uploading of the document to the website is specified. In order to accurately calculate the number of working days from the date of the meeting to the date of publication of the SCP decision, we used the free and publicly available platform — www.timeanddate.com<sup>5</sup>.

#### **Consultation of Paper and SCP Feedback**

In addition, the draft paper and its main recommendations were consulted at a public event held on 26 October 2023<sup>6</sup>, with the participation of judicial experts, including SCP members. In their speeches, SCP representatives pointed out that the comments in this report were constructive but could not be accepted in their entirety because the drafting methodology was not complex enough and stressed the need to consult all SCP members. <sup>7</sup>

In light of these arguments, on 27 October 2023, and subsequently on 21 November 2023, the LRCM sent the draft report to all SCP members for consultation, noting that any suggestions, objections, and improvements were welcome. It should be noted that the subject of the LRCM report was on the agenda of several SCP meetings in November

2023, but its consideration did not take place for various reasons. On 24 November 2023, the SCP took note of the draft report in a protocol format and mentioned that a consolidated opinion on the subject would be formulated and submitted to its authors.8

On 18 December 2023, the LRCM received the positions of some SCP members, seconded prosecutors9, and the main issues raised have been included in the text of this report.

# ORGANIZATION AND CONDUCT OF SCP MEETINGS


According to the law, the SCP meets as often as necessary, but at least once a month. Similarly, SCP meetings are deliberative if at least 2/3 of its members participate. Participation in SCP meetings may be by physical presence at the meeting location or by teleconference, provided that it is possible to identify an SCP member and confirm his or her ability to vote.10



During the reporting period, the SCP scheduled 109 meetings, of which 90 (83%) were held and the remaining 19 (17%) were postponed, mainly due to lack of quorum.

Of the total number of postponed meetings, 17 were regular meetings and two were extraordinary meetings.

In 2020, 24 meetings were scheduled, of which 2 (8%) were postponed. In 2021, 25 meetings were scheduled, of which 1 (4%) were postponed. In 2022, 41 meetings were scheduled, of which 10 (24%) were postponed. In the first half of 2023, 19 meetings were scheduled, of which 6 (31.5%) were postponed. These data are also confirmed by the SCP in its Summary of Activities for 2018-2023.11


It should be noted that although fewer meetings were held between 2020 and 2021 than in 2022, they were better organized in terms of attendance and the quorum required to hold a meeting. The rate of postponement of meetings in the first two years of monitoring is very low, as an SCP meeting took place almost every other week during this period. On the other hand, between 2022 and the first half of 2023, the rate of postponement of meetings is quite high (from 25% to 31.5%), with the lack of quorum being the main reason why meetings could not be held.

"Someone from the SCP administration would call me and ask if I was available on a certain date and at a certain time. Sometimes it was ugly, because although I had said I couldn't be there, I would see in the agenda that I was also a rapporteur on a certain topic...".

(Interview with SCP ex-member — September 2023)

This suggests either that the agendas of SCP members are overloaded, or that there is a lack of willingness to come to a meeting, or, no less importantly, that the subjects proposed for the agenda were placed there without regard to the positions of most SCP members.

Out of a total of 19 adjourned meetings, 5 meetings (26%) were attended by all SCP members who were seconded prosecutors and 1-3 *ex officio* or civil society members of the SCP. Seven meetings (37%) were attended by 3 or 4 prosecutor members of the SCP. Only one meeting was attended by only 2 prosecutor SCP members. However, this meeting was also attended by two *ex officio* and/or civil society members of the SCO. For four adjourned meetings, no video recordings were posted, i.e. we have no data on the attendance of members. As a rule, between 1 and 3 SCP members – prosecutors and *ex officio* and/or civil society members – attended the adjourned sessions, but never more than three.



From the data reviewed, it appears that during the period under review, meetings were postponed more often due to the absence of *ex officio* and/or civil society members, which was publicly criticized by the seconded prosecutor members of the SCP.<sup>12</sup> However, in January-February 2023, the reaction of the *ex officio* and/or civil society members was published<sup>13</sup>, according to which their non-attendance was due to the fact that the agendas of the meetings included issues related to the appointment of the winners of competitions to fill senior positions and the appointment of graduates of the National Institute of Justice as prosecutors. The *ex-officio* and/or civil society members of the SCP noted that there were more than 60 applications to be considered, which would require a great deal of work and time, and requested that these subjects be removed from the agenda. However, the prosecutor members insisted on keeping those topics, which is why ex officio and/or civil society members did not attend those meetings. This shows poor and unconstructive cooperation between seconded prosecutor SCP members and the *ex officio* and/or civil society members.

#### **Regular vs Extraordinary Meetings**

Of the 109 meetings, 11 (10%) were extraordinary (0 meetings in 2020; 3 meetings in 2021; 4 meetings in 2022 and 4 meetings in the first half of 2023), i.e. they were convened quickly to deal with urgent matters. Most of the issues included in the extraordinary review related to the evaluation of the Prosecutor General's performance, the related procedures for the selection of an Acting Prosecutor General, a candidate for the position of Chief Anti-Corruption Prosecutor, or the request for suspension and cancellation of the competition for the selection of a candidate for the position of Chief Prosecutor of the Prosecutor's Office for Combating Organized Crime and Special Cases (PCCOCS). While we do not deny the need to convene the SCP for urgent consideration of such matters, matters relating to appeals of decisions of the Discipline and Ethics Board, approval of cumulation of prosecutorial and teaching duties, honoring prosecutorial anniversaries, or appointing SCP members to various task forces<sup>14</sup>, etc., can be planned and considered at regular meetings.

According to the wording of point 6.2. of the SCP Rules of Procedure, the only difference between regular and extraordinary meetings is who can request the convening of the meeting ("the Chairperson or 3 members of the SCP"). The rule in the Rules of Procedure

does not distinguish between the two and does not specify how much notice is given to SCP members before the meeting. In our view, the "extraordinary meeting" can and should be organized for "unforeseen matters that cannot be postponed".

The SCP Rules of Procedure state that the date and place of a regular meeting are usually set at the preceding meeting. The SCP members we interviewed claimed that there are "other ways of working".

"In my experience, the day of an SCP meeting is determined in three ways.

- 1) Everyone checks their personal agenda after the current meeting is over.
- 2) Everyone chats and discusses a date in advance. 3) Discretion of the SCP Chairperson ..."

(Interview with a SCP member – September 2023)

By comparison, in the case of the Superior Council of Magistracy (SCM), the Secretariat sends the agenda, date, time and place of a meeting to the members at least three days before the meeting, except for extraordinary meetings. 15 In the case of Integrity Council meetings, the Council shall convene at the request of the Chairperson or at least three members a) at least three days prior to the date of a regular meeting; or b) at least 12 hours prior to the date of an extraordinary meeting.<sup>16</sup>

In order to avoid uncertain situations involving the discretion of some SCP members, on the one hand, and to avoid postponements, on the other hand, we recommend that SCP members reflect on the current mechanism for convening meetings, the types of issues that should be considered in extraordinary meetings, and, if necessary, to refine the SCP Rules of Procedure in this regard. The extraordinary meeting mechanism should be used only when there are truly urgent matters that cannot be postponed.


#### "Day" of SCP Meetings

Of the 109 meetings, most – 49 (45%) – were scheduled and/or held on Thursdays. Twenty-five (23%) meetings were scheduled and/or held on Fridays, sixteen (14.7%) on Tuesdays, ten (9.2%) on Wednesdays, and eight (7.3%) on Mondays. One extraordinary meeting was also scheduled for a Saturday, but was postponed. 17

We found that the practice of holding SCP meetings on Thursdays was common in 2020-2021. From the second half of 2022 to mid-2023, holding SCP meetings on Thursdays was no longer the rule. Meetings were scheduled unpredictably. It seems that this change was due to the unavailability of some members on Thursdays. This lack of consistency in scheduling meetings can create confusion and undermine the transparency and predictability of the SCP's activities. According to SCM prosecutor members, due to the lack of a quorum, meetings have recently been exceptionally planned and "tailored to the availability of all members". This was the reason for the deviation from the usual way of organizing SCP meetings on Thursdays. 18

In order to ensure a high level of transparency, effective communication with the public, and predictability, we recommend that SCP members return to the previous practice of setting a specific day for regular meetings. We understand that there may be some exceptions in the setting of meetings, as the agendas of *ex officio* members of the SCP (Minister of Justice, SCM Chairperson or Ombudsman) may be overloaded and this may cause some deviations; however, a general rule should be established at the level of SCP practices to introduce more predictability in everyone's agenda. By way of comparison, the SCM holds most of its meetings on "Tuesdays" and the Audiovisual Council on "Fridays".

#### Viewing of SCP meetings

SCP meetings are audio and video recorded. The video recording of a meeting, except for closed meetings or closed portions of meetings, is broadcast in real time on the SCP website. The video recording of a meeting is also stored on the institution's website. In addition, to increase the visibility of its work, the SCP uses modern communication tools, such as live streaming of meetings on its Facebook page.

We have never experienced technical problems in viewing SCP meetings online or from the archive (stored on the website). Recordings of 105 meetings have been posted on the SCP website.19

However, we have found that each time the SCP uses a private company's platform to broadcast and record its meetings. The private company's broadcast of meetings is expensive and subject to availability.

On the other hand, we found that SCP meetings were not archived in their entirety; the private platform/provider removed/deleted the video content and time intervals while a meeting was closed or during "deliberations". We recommend that SCP members consider the need to purchase and use their own equipment to broadcast and record meetings. Private platforms that wish to broadcast audio/video of SCP meetings should still be allowed, but as an alternative to the SCP's own equipment and electronic system.

According to the SCP's response of December 2023, the best solution until September 2023 was to hire a company, as the purchase of its own technical equipment for audio/ video recording would have involved significant costs that the SCP did not have at the time. <sup>20</sup> As of October 2023, all SCP meetings have been broadcast and recorded using proprietary equipment.21

#### **Early Posting of Agenda**

According to the SCP Rules of Procedure, the agenda of a meeting must be posted on the official website at least two working days prior to the date of the meeting. This task is performed by the SCP administration.

The agenda for a meeting is prepared by the head of the SCP administration in consultation with the SCP Chairperson. Any SCP member may propose subjects for the agenda at least three working days before the meeting.

During the monitoring period, 109 agendas posted on the SCP website were identified. Of the total number of agendas, 15 (14%) were posted after the deadline set by the SCP Rules of Procedures. Of these, 11 agendas were posted the day before the meeting and the other four were posted on the day of the meeting. According to SCP members, such

cases of late posting were due to uncertainty about the availability of some *ex officio* and civil society members and, rarely, to technical problems.<sup>22</sup>

However, we believe that the reasons given are not sufficient. The late publication violates para. 5 of Art. 77 of Law 3/2016 and the Rules of Procedure of the SCP, which affects the transparency and predictability of its activities.

#### **Supplemental Agenda**

The SCP Rules of Procedures provide that subjects that cannot be postponed shall be included in the supplemental agenda, which shall be sent to SCP members by e-mail and posted on the official website prior to the start of the meeting.

During the monitoring period, 31 supplemental agendas posted on the SCP website were identified. A total of 39 subjects were included in the supplemental agendas. Most of them came from the Prosecutor General (including the Acting Prosecutor General) requesting changes in the structure of the Prosecutor's Office, promotion, advancement or transfer of prosecutors.<sup>23</sup> In many cases, the Prosecutor General himself acted as rapporteur on issues or, in the case of the Acting Prosecutor General, some SCP members acted as rapporteurs to support the approval of his orders to ensure the interim arrangement for senior positions in prosecutorial bodies. According to the prosecutor members of the SCP, the subjects received from the Prosecutor General are already based on some individual administrative acts signed with a "special note of urgency" and, in order not to delay them, they are included in the supplemental agenda.<sup>24</sup>

However, in our opinion, transfer, promotion, and interim assurance subjects are not subjects that should not be postponed. They should be placed on a regular agenda so that all SCP members have sufficient time to review them. We recommend that SCP members consider the need to detail the subjects for a supplemental agenda in the SCP Rules of Procedure.


#### **Subjects Placed on SCP Agenda**

From 1 January 2020 through 30 June 2023, the SCP placed 805 subjects on the agenda (including 39 on supplemental agendas).

One hundred and twenty-four (15%) subjects dealt with the selection, performance, and career of prosecutors; 203 (25%) — with discipline and ethics of prosecutors, and 83 (10%) — with approval of priorities and activity reports of the SCP, subordinate bodies, various normative acts and policy papers, organization of the General Assembly of Prosecutors or selection of the leadership of the Prosecutor General's Office. Such issues account for 50% of the workload of SCP members. The other 50% of the work is related to the examination of requests to combine the prosecutor's office with teaching and scientific activities; notices of competitions; submission of applications for the prosecutor's office to subordinate bodies for consideration; examination of various institutional requests; addresses or appeals that do not fall within the disciplinary field, or requests for the appointment of SCP members to various councils or working groups, etc.

#### Closed Meeting Discussions and "Deliberations"

As a general rule, SCP meetings are open to the public. Exceptionally, the SCP may decide by reasoned decision to close all or part of a meeting in order to comply with restricted information or privacy rules. According to the Rules of Procedure of the SCP<sup>25</sup>, information on the activities, career and assets of a prosecutor or a candidate for a prosecutor's office is not restricted information or personal information, except for information that constitutes a state secret.

Only SCP members, staff and persons invited by the SCP have access to a closed meeting. By decision of the SCP, closed meetings may also be attended by persons affected by the situation under discussion. The press is not permitted to attend closed meetings.

The Law on the Prosecutor's Office does not provide for a mechanism to discuss issues "in deliberation" within the SCP. On the other hand, the Rules of Procedure of the SCP allow the deliberation of appeals against the decisions of the Disciplinary and Ethics Board, as well as the evaluation of civil society members of the Boards.

We set out to estimate the actual time allocated and the duration of SCP meetings for the entire monitoring period. Since most of the SCP meetings were archived without the actual duration of "deliberations" and/or without the time allocated to closed meetings, we could not estimate the actual participation in SCP meetings.

However, we found that "without deliberations" and without closed meetings, the SCP members spent an average of 76 minutes per meeting in the 109 meetings. On the other hand, meetings "with deliberations" and/or closed meetings lasted a full working day (8 hours) in some cases.<sup>26</sup>

This allows us to objectively see that "deliberations" or subjects discussed in closed meetings sometimes last longer than subjects discussed by SCP members in open meetings.

Similarly, according to our monitoring results, 369 subjects were discussed in open meetings and 289 subjects were discussed in closed meetings or the final decision on the subject under discussion was made "in deliberation". Another 217 subjects were removed from the agenda and/or their discussion was postponed to other meetings.

This means that one-third of all SCP work takes place in closed or "in deliberation" sessions. In our monitoring experience, the rapporteur of an subject comes forward at the beginning of its consideration with a proposal that the consideration take place in a closed meeting. We saw no objections from other SCP members, and the rapporteur's proposal was always accepted. We find it unacceptable that such matters as the appointment of a prosecutor member to the Board of the National Institute of Justice;<sup>27</sup> the combination of prosecution with teaching;<sup>28</sup> the designation of winners of advertised competitions, even when there are three

applicants for three positions<sup>29</sup>, etc., should be discussed in closed session or "in deliberation".

Similarly, we found that the issues related to appeals against decisions of the Disciplinary and Ethics Board were considered only in closed meetings. There was even a case in which the lawyer of the former prosecutor involved in the appeal against a decision of the Disciplinary and Ethics Board expressly requested an open meeting, but the SCP members, arguing that personal data were involved, decided by vote to consider it in a closed meeting.30

This is illogical, since the meetings of the Disciplinary and Ethics Board are public (with some exceptions), as expressly provided for in point 32 of the Rules governing the organization and functioning of the Disciplinary and Ethics Board.31 Although the meetings of the specialized board are not broadcast online, it is clear from the legislation that they are open to the public. The same rule of transparency applies to SCP meetings, as consideration of subjects in closed session is an exception. In other words, it is wrong that every subject on the SCP's agenda relating to prosecutorial discipline and ethics should be considered entirely in closed session. This significantly diminishes the transparency of the self-governance body of prosecutors.

Although the law requires that SCP meetings be open to the public, with the necessary exceptions, our monitoring shows that closed meetings seem to be the rule, while public meetings are the exception. Moreover, although the decision to hold a closed meeting should be made by a reasoned resolution, this provision is not followed. In practice, the SCP members voted on this subject without providing an eloquent and conclusive justification for the urgent need to deviate from the general rule.

#### **Publication of Minutes**

The work of the SCP is recorded in minutes, which include the attendance of SCP members and others, a summary of the debates and decisions made, and the distribution of votes

According to the SCP Rules of Procedure, the minutes of the meeting shall be prepared by the Secretary of the meeting within three working days of the date of the meeting. They are signed by the SCP Chairperson and the Secretary of the meeting. As a general rule, minutes are posted on the website after they have been signed. However, the

minutes of closed meetings, or of the portion of meetings conducted in closed session, are not posted. Any person may obtain excerpts from the minutes of an open meeting of the SCP.

During the monitoring period, only five minutes published on the SCP website were identified. <sup>32</sup> The last published minutes are from May 2020. It seems that the minutes have been replaced by so-called "settled agendas", which are supposed to be summaries of SCP meetings. It should be noted that settled agendas have been published in parallel with the minutes since the beginning of 2020. We identified 90 documents posted on the SCP website for the period under review.

The agenda lists the subjects discussed, the solutions adopted for each subject, and sometimes, at the end, the attendance of SCP members. Although their format purports to meet the requirements of the SCP rules for minutes, they do not represent a summary of the debates on an issue or the distribution of votes of SCP members. According to prosecutor members of the SCP, the minutes are not published because it takes time to anonymize the data, which is done manually in the SCP administration. Lack of additional human resources is also a problem in this regard.<sup>33</sup>

However, we recommend that SCP members and administration consider the compatibility of the "agenda" with the minutes provided in the Rules of Procedure. Either the Rules of Procedure need to be amended or more care needs to be taken when completing and finalizing the agenda to ensure that all necessary aspects are included. In order to improve the transparency of the SCP, we believe it is necessary to return to the practice of publishing the minutes of the meetings.

#### SCP DECISIONS

#### **Consistency of Votes and Dissenting Opinions**

The SCP makes decisions by open vote of the members, with the exceptions specified in the SCP Rules of Procedure. SCP members must vote in favor or against. Voting is normally by show of hands. The SCP Chairperson casts the deciding vote.

Any SCP member is entitled to submit a dissenting opinion. The SCP member shall announce the writing of a dissenting opinion immediately after the voting process is completed.

During the monitoring period, we identified 15 dissenting opinions written by a single SCP member or in collaboration with others. Only one dissenting opinion was concurring<sup>34</sup>, while the others expressed disagreement with the majority opinion. <sup>35</sup> In most cases, the dissenting opinions were written by two SCP members.

The trend towards dissenting opinions became more pronounced from February 2022 and continued until the end of the monitoring period in June 2023. In the 2020-2021 period, only two dissenting opinions were issued by two SCP prosecutor members. In most cases, a dissenting opinion was not preceded by an adversarial discussion of the issue in open session. Therefore, in closed session, or "in deliberation," some SCP members actually presented their arguments and conflicting positions in relation to the majority decision.

According to official SCP data, 730 decisions were taken between January 2020 and August 2023 (in 2020 - 132 decisions; in 2021 - 169 decisions; in 2022 - 282 decisions; and by the end of August 2023 – another 147 decisions).<sup>36</sup> These data confirm that in 2022-2023, when there were the most dissenting opinions, they were written in only 3% of the decisions. SCP members vote mostly unanimously, and public discussions are rarely adversarial (with the exception of some periods in 2022). SCP members have not objected to the appointment of competition winners, proposals for interim appointments, etc.

We recommend that if an SCP member prepares a dissenting opinion, it should be included as part of the SCP decision (in the same pdf document).

#### **Date of Publication of SCP Decisions**

The decisions of the SCP are published on the official website no later than 10 working days after their adoption, in compliance with the personal data regime, restricted information and/or the principle of confidentiality.

During the period under review, we identified 568 SCP decisions posted on the official website (see Appendix 1 for details). Of these, only 23 (4%) were posted on time. Of these 23, the majority (12) were posted on the last day of the ten-day period. This indicates a flagrant and systematic failure to comply with the deadline for the publication of SCP decisions.

A further 21 SCP decisions were published in scanned pdf format, making it impossible to determine the date of publication, or some had not yet been published on the website at the time the report was finalized. Some SCP decisions adopted as early as 2021 could not be found on the SCP website.

The average time taken to publish an SCP decision on the website is 42 working days, four times the legal deadline.

The SCP members interviewed said that the work of the SCP depended on the support and assistance of the SCP administration which was not fully staffed.

"They are published late because of a lack of staff. Hiring more staff will hopefully solve the problem"

(Interview with a SCP member – September 2023)

Two SCP decisions were found to have been published within one day of approval.<sup>37</sup> On the other hand, five

SCP decisions were found to have been published more than 520 working days after adoption<sup>38</sup>, and one decision even more than 651 working days after adoption<sup>39</sup> All of these decisions concerned the consideration of appeals against decisions of the Disciplinary Board or the suspension of the Chief Prosecutor.

SCP decisions of an individual nature take effect from the moment they are issued. In interviews with some SCP members, we were informed that most SCP decisions on prosecutorial discipline are challenged in court. Late publication of a reasoned decision will undoubtedly also delay subsequent court proceedings.

We consider the late publication of SCP decisions to be a major problem. It is a serious violation not only of para. 7 of Art. 77 of the Law on Prosecutor's Office and the Rules of Procedure of the SCP, but also seriously affects the transparency of the SCP.

We have found that there is a reluctance to use electronic signatures to sign SCP decisions, even though the legislation provides that in the final version they may be signed by holography or electronic signature by all members who participated in their adoption. This reluctance is difficult, if not impossible, to justify.

"The SCP administration practically does not accept electronic signatures, only holographic ones. Sometimes some SCP members are abroad and it is convenient to sign electronically. The signing of the decision is delayed until they return to the country."

(Interview with SCP member – September 2023)

The SCP needs to take steps to fill vacancies in its Secretariat in order to reduce the workload of existing staff. Similarly, we invite the members of the SCP to consider the advisability of amending the Law on Prosecutor's Office, and subsequently the SCP Rules of Procedure, by giving the SCP Chairperson the authority to sign certain types of decisions without the need for the signatures of all members, as they have previously raised their hands and voted

Finally, we recommend the use of electronic signatures by SCP members to make it easier and quicker for them to sign adopted decisions.

#### **Prosecutor General's Requests**

During the monitoring period, we identified 63 demarches or requests from the Prosecutor General (including the acting Prosecutor General) that were considered by the SCP.

As a rule, the requests of the Prosecutor General fall into two categories. The first category concerns the priorities of the work of the Prosecutor's Office and changes in the structure of the Prosecutor's Office, and the second category concerns the appointment and approval of interim appointments to senior positions in the Prosecutor's Office, suspension from office or transfer of prosecutors from one Prosecutor's Office to another (until the recent changes in the law).

Previously, the LRCM found that the institution of transfer at the request of the Prosecutor General was a powerful lever to influence prosecutors' careers. 40 Most of the transfers were from the territorial prosecutor's offices to the Chisinau Prosecutor's Office. *De facto*, the transfer of prosecutors from the regions to Chisinau is seen by most prosecutors as a promotion, and the non-transparent and discretionary exercise of the transfer *de facto* became a means to ensure the loyalty of prosecutors to the Prosecutor General.

It is not clear how the Prosecutor General identifies the prosecutors to be transferred. However, we noted that all of Prosecutor General Stoianoglo's transfer proposals had been unanimously accepted by the SCP members without objections.

During the monitoring period, we observed that only eight requests from the Prosecutor General, including the Acting Prosecutor General, were discussed in an adversarial manner, with several questions or objections put to him. However, they were accepted by the SCP members but the reasons for their decision were not clear as in the case of seven of the eight requests, the final decision was made "in deliberation".

#### LACK OF REASONING IN SOME SCP DECISIONS

SCP decisions must be justified. Normally, a draft decision is prepared by the SCP administration together with the rapporteur member before the SCP meeting. The final version of the reasoned decision is prepared within five working days of its adoption.

When analyzing the decisions published on the SCP website, we found that their reasoning was vague, with more emphasis on the legal circumstances and the technical implementation of legal provisions, without detailing the factual circumstances and, in particular, without describing the SCP's reasoning on which the decision was based.

Of particular interest are decisions approving or rejecting interim measures ordered by an Acting Prosecutor General. For example, several cases were identified where the SCP approved several interim arrangements in the same decision, but rejected others without explanation.<sup>41</sup> Subsequently, the SCP ex officio approved decisions ordering interim appointments to previously rejected posts, again without any eloquent justification and without describing the reasons and facts.42

The answer given by the prosecutor members of the SCP does not deny this aspect; in these cases the authority confined itself to applying the legal provisions, but did not provide any explanation as to why it had rejected the interim order issued by the Acting Prosecutor General, or why he issued the interim order specifically for that person chosen ex officio, how he arrived at that candidature, whether or not other persons had been reviewed etc.

The analysis shows a lack of transparency in the approval or rejection of interim arrangements. In addition, there is still a significant lack of justification for the ex officio appointment of persons as interim holders of certain senior positions in the Prosecutor's Office.

#### **Contest Winner Announcement**

The SCP's practice of interviewing candidates in the same competition, for the same post, at the same time, in the same room, one after the other, without any preestablished criteria, order or common list of questions, was noted.<sup>43</sup> In such a situation, the last candidate would, for example, be more favored or would have more time to think or simply to answer some questions than his counterparts.

We recommend that SCP members consider the following details:

- Ensure that each candidate is heard individually, so that there is no possibility of the other candidates knowing the guestions;
- Ask all candidates the same standard questions.

#### CONCLUSIONS

**Organization of SCP meetings** – between January 2020 and June 2023, out of a total of 109 scheduled meetings, 90 (83%) were held and 19 (17%) were postponed due to lack of quorum.

Fewer meetings were held between 2020 and 2021 than between 2022 and June 2023. In the second period, the number of postponed meetings increased significantly. Lack of quorum was mainly due to the absence of SCP ex officio or civil society members. Some of them justified their absence by saying that the agenda included important issues, such as the appointment of winners of competitions for senior positions in the Prosecutor's Office without sufficient time for preparation. SCP prosecutor members insisted on keeping these topics, which is why ex officio or civil society members did not attend these meetings. This suggests a lack of communication between prosecutor members and ex officio and/or civil society members.

**The "day" of the SCP meetings** was Thursday in most cases (45%). This trend was more pronounced in 2020-2021. From 2022 onwards, SCP meetings were scheduled unpredictably. This factor is likely to contribute to an increased number of postponed meetings. The SCP should establish a predictable day of the week for regular meetings.

**Extraordinary meetings** accounted for 10% of all scheduled meetings. These should only be used to discuss important matters that cannot be postponed. However, several instances were identified where matters that could be discussed at regular meetings were included, such as consideration of disciplinary appeals, approval of multiple employment.

Viewing the meetings online was possible without technical problems. However, we found that the SCP uses a private company's platform to broadcast and record meetings. This is costly and risky, and there is a dependency on the availability of the private company to broadcast the meetings. In addition, the private platform does not keep the full video recordings and removes the intervals when the meeting is closed or the "deliberations" last.

The meeting agendas (including supplementary agendas) contained a total of 805 subjects. Only 50% of these subjects were related to the fulfillment of the main responsibilities of the SCP. One hundred and twenty-four (15%) of the subjects were related to the selection, performance, and career of prosecutors; another 203 (25%) were related to the discipline and ethics of prosecutors; and 83 (10%) of the subjects were related to the approval of the activity reports of the SCP and subordinate bodies, various normative acts and policy papers, the organization of the General Assembly, or

the selection of the leadership of the Prosecutor General's Office. At least 14% of the regular agendas were published after the legal deadline.

Of the 31 supplementary agendas containing 39 subjects, the majority were from the Prosecutor General, including the Acting Prosecutor General, and concerned transfers, promotions, securing interim appointments, etc. These subjects do not fall into the category of non-postponable subjects and could have been included in the regular agendas, allowing all SCP members sufficient time to consider them.

**Discussion of issues in closed session and 'in deliberation'** – seems to be the rule while public meetings – the exception, although the law provides otherwise. There were meetings, including partially closed ones, that lasted up to eight hours in total, but the average length of a public meeting and "without deliberation" is only 76 minutes.

Of the 805 subjects on the agenda, 369 were discussed in open session, 289 were discussed in closed session or the final decision was taken 'in deliberation' and 217 subjects were deferred. This means that approximately 33% of the matters considered by the SCP were discussed without society having access to them. All matters related to disciplinary proceedings against prosecutors were discussed in closed session. This practice is all the more difficult to explain as the meetings of the Disciplinary Board of prosecutors are open to the public.

Although many of the issues related to prosecutors' careers were discussed in closed session, public meetings revealed the SCP's practice of interviewing candidates for the same position at the same time, without a standardized order or list of questions.

In general, the Prosecutor General's requests were accepted without debate, especially in 2020 and 2021. In the other monitoring period, the Acting Prosecutor General's requests could be discussed at the meeting and decisions were made "in deliberation". It is noteworthy that even the divergent views of some SCP members were not necessarily preceded by a confrontational discussion of the issue in open session. Most of the contentious issues were discussed 'in deliberation'. As a result, the reasoning behind the SCP members' decisions was not clear.

**The publication of minutes** was replaced by the publication of so-called "settled agendas". Only 5 minutes were identified. The agenda does not comply with the SCP Rules of Procedure as it does not include at least a summary of the debates by subject and the distribution of votes of the SCP members.

**SCP decisions** are published on the official website with systematic disregard for the legal deadline. Of the 568 decisions identified, only 23 (4%) were published on time. The average time taken to publish a decision is 42 working days, four times the

legal deadline. SCP decisions were identified that had been published more than 520 working days after adoption, and others from 2021 had not been published at the time of writing. SCP members cited a lack of staff within the SCP administration as the reason for this delay.

The reasoning of the SCP's decisions is usually vague, with more emphasis on the legal circumstances and the technical implementation of legal provisions than on the factual circumstances and the SCP's reasoning behind the decision. This practice was most often observed in the case of approval or rejection of interim appointments in the prosecutorial system.

**Final conclusion**: The widespread practice of discussing issues in closed session and "in deliberation," together with the inadequate justification for some types of decisions and the rather late publication of all decisions, significantly reduces the transparency of the SCP's activities.

### RECOMMENDATIONS

#### **Organization and Conduct of SCP meetings**

- Designate a specific day of the week for regular meetings and hold extraordinary meetings only for subjects that cannot be postponed.
- Since the supplemental agenda also includes subjects that cannot be postponed, the SCP should specify in the SCP Rules of Procedure which subjects should be included in the supplemental agenda so that all SCP members have sufficient time to consider them.
- Ensure that the SCP broadcasts and records meetings using its own equipment, not that of a private company.
- Ensure that each candidate's individual interview (if there are multiple candidates) is based on a standard set of questions.

#### **Discussion of Issues at SCP Meetings**

- Strictly adhere to legal requirements that matters be considered and discussed in open meetings, and ensure that closed meetings are the exception rather than the rule. In this regard, it is useful to establish and publicly communicate the criteria that would determine when an subject, or part of an subject, should be considered in closed session. Discussion of matters such as appointments, results of competitions and other matters should not take place in closed session, except in exceptional and justified cases involving data protection or restricted information.
- Eliminate the practice of announcing "deliberations" when they are not necessary. They may be retained only for disciplinary decisions.

#### **Publication of SCP Documents and Decisions**

- Resume the practice of publishing the minutes of SCP meetings, as required by the SCP Rules of Procedure.
- Fill vacant positions or increase the number of staff within the SCP administration.
   This will alleviate the problem of late publication of SCP agendas and decisions.
- Encourage SCP members to use electronic signatures to make it easier and quicker for them to sign decisions.
- Improve the justification for decisions to approve or deny interim arrangement for senior positions.
- Publish a dissenting opinion as part of the SCP decision (in the same pdf document).
